
**PROVISIONS OF SGT. DARRELL S. COLE MEMORIAL SHOOTING RANGE
CONTRACTUAL AGREEMENT
FOR CALENDAR YEAR 2017**

This letter will serve as a contractual agreement between your law enforcement agency or individual officer and the Sgt. Darrell S. Cole Memorial shooting range, in conjunction with the Mineral Area College Law Enforcement Academy CEH Contract Training Agreement for the calendar year *2017*. The provisions of this training agreement are as follows:

1. You or your department must hold a current contract with the Mineral Area College Law Enforcement Academy Continuing Education Program.
2. For the period of January 1, 2017 through December 31, 2017, the Sgt. Darrell S. Cole Memorial Shooting Range will provide law enforcement only range dates to conduct training and firearm qualifications for your department. These hours will be as follows:
 - a. **Thursday from November 1-February 28**
 - b. **Monday and Tuesday from March 1-October 31**
3. Individual contracted officers may use the range at no additional cost on all open range dates (whether it is an agency contract or individual contract) with the exception of special events and closed days. The officer must be on the department contract list and photo ID is required at each visit.
4. Contract Cost:
 - **1-5 Officers \$50 per officer per year**
 - **5-15 Officers \$250.00 per department per year**
 - **16-30 Officers \$350.00 per department per year**
 - **31 and over Officers \$500.00 per department per year**

NOTE: The Contract Training Fee is Non-Refundable, although it may be transferred to another officer if it's paid for by an agency or department on a case by case basis, as decided by the Director of the Law Enforcement Academy.

The attached Continuing Education Contract Registration Form must be **completed and returned by March 15, 2017 by 4:00 p.m.** Open enrollment under these provisions closes after that date.
