

# ADVANCED PLACEMENT (LPN TO RN Bridge)

## for 2027-2028 Program

### THE COLLEGE

Graduates of the Associate of Science in Nursing program are prepared to perform nursing services as a beginning practitioner inclusive of assessing the health status of individuals with more complex health problems; develop, modify and set goals for client care; delegate nursing responsibilities as team leaders; and evaluate and write revisions in the plan of care for clients with preventative and commonly occurring health problems.

Upon successful completion of the program, the graduate should be eligible to apply to take the National Council Licensure Examination for Registered Nurses (NCLEX-RN).

Successful completion of the program, however, does not guarantee eligibility to take the licensure exam or to become licensed.

Satisfactory achievement on the licensure exam will qualify the program graduate for licensure as a Registered Nurse (RN).

### ENTRANCE REQUIREMENTS

1 a) Be a graduate of an approved program in Practical Nursing and successfully pass the NCLEX-PN licensure exam on the first attempt within 90 days of graduation. *Without successfully passing the NCLEX-PN, students will take all credit hours and clinicals in Medical-Surgical I and II.*

**OR**

b) Have a current Missouri license in Practical Nursing.

2. Have basic computer knowledge as evidenced by a high school or college computer course.

3. Test of Essential Academic Skills (TEAS) test score with the following minimum:

Minimum TEAS composite score accepted	
Proficient	58.7

4. Completion of the following courses, with a grade of C or above. Completed courses used for GPA selection:

- ENG1330 [ENGL100] English Composition I
- MAT1240 [MATH120] Quantitative Reasoning\*
- BIO2600 Human Anatomy^
- BIO2620 Human Physiology^
- NUR1290 Fundamentals of Nursing^^

Prerequisite courses must be completed by MAC's commencement in the spring semester of the application year.

5. Minimum grade point average (GPA) based on the five (5) prerequisite courses of:

- 2.5 for the Associate of Nursing Program

6. Successful general application and acceptance to Mineral Area College before the nursing application deadline.

7. Completion of a Dosage Calculation and Medication Practicum Exam with a passing grade (will receive date once selection is made).

**Application to the nursing program, along with the requirements in this publication, must be submitted by 3 pm on March 8, 2027 (deadline) to the Allied Health Department at Mineral Area College.**

### APPLICATION PROCESS

- 1) Apply to MAC and be accepted
- 2) Complete nursing application. Applications accepted from 08/24/26 until 3 pm on 03/08/2027
- 3) Request that official copies of dual credit and transfer transcripts be sent to MAC
- 4) Achieve a TEAS composite test score of proficient or higher

**TEAS test must be completed by MAC's spring commencement of the application year and must be no older than 2 years from this date.**

^^^Selection is based on two (2) criteria:

- GPA calculated from prerequisite courses
- TEAS composite test score

All applicants accepted into the program are considered on conditional status pending:

- Submission of required citizenship documentation
- Passing a drug screen
- Passing a background check
- Compliance with immunization criteria
- Obtaining Basic Life Support (BLS) Certification

(Student must maintain current BLS for the length of the program)

- 1 a) Applicants to the Advanced Placement program must be a graduate of an approved program in Practical Nursing and have successfully passed the NCLEX-PN licensure exam on the first attempt within 90 days of graduation.

Without successfully passing the NCLEX-PN, students will take all credit hours and clinicals in Medical-Surgical I and II.

**OR**

- 1 b) Have a current Missouri license in Practical Nursing.
